## **Annual Fund**

Our FOCUS program is an intregral part of our mission to *prepare disciples for the Church and the world*. Current annual cost to host 5 missionaries to serve the University of Iowa campus alongside our staff is \$78,000.

# **Our Priest Director**

Fr. Jeff Belger, accepted the role of Priest Director in 2018. Prior to that, he served as Priest Campus Minister at the center as well as Parochial Vicar at St. Mary of the Visitation parish in Iowa City. Fr. Jeff began his discernment to the priest-hood while a student at Notre Dame High School in Burlington, IA. Prior to the priesthood, he worked as a YMCA Program Director and then as a teacher and Youth Minister at Notre Dame High School. He earned both his MA and MDiv in Theology at St. Meinrad School of Theology.

Being self-funded means we work to make the most of every gift to the Center. Our staff works hard to be efficient and resourceful with gifts from our partners. Operating funds allow us to provide the best facilities and resources for students.





# Endowment Fund Partnership Opportunities allow benefactors to support our ministries through several funds that support designated areas of our ministry to students. Endowment funds are designed to keep the princi-

pal amount of gifts intact while the organization uses the investment income/interest as a funding stream.

- Outreach & Education to supports student outreach and faith formation through the funding of outreach department staff.
- Fellowships and Scholarships allows for stipends to be awarded annually to student leaders who serve as fellows and scholars in these areas: Service & Social Justice, Liturgical Ministry, Prayer & Worship, Faith Formation, Outreach, and Communications.
- Louise Wolf-Novak Service & Social Justice was established in 2017 in memory of Louise Wolf Novak and funds the Social Justice fellow and enhances social justice programs offered at the center.
- Helen & Nicholas Rossi Center for Faith & Culture funds two
  nationally or regionally recognized speakers to preset on cultural
  topics that impact the lives of students.
- Pieroni Funds for Communication Fellows was established to fund the Communications Fellow stipend. This fund is not currently fully funded.
- Fr. Ed Fitzpatrick Discipleship Award allows the Newman Center
  to annually recognize 10-12 alumni who carry on our mission of discipleship through their work within a Catholic parish or other non
  profit. A \$500 financial gift is made to the respective parish or non
  profit in the name of the recipient.

## **How Do You Calculate Your Return on Investment?**

It is hard to assign a dollar return on investment to your gift. We feel that our students show the true impact that our ministry has on the University of Iowa community through how they live their faith during and after their college years.

Although he thought about the priesthood during his high school years, Thomas Kollasch made the decision to attend UI. Joining the Newman Center at the invitation of a FOCUS misisonary, Thomas says he learned what it meant to live a reflective lifestyle in the joy of choosing Jesus through the discipleship of the FOCUS program. His favorite memories of the center are Thursday Night Mass with Fr Jeff and hearing the messages of visiting priests. He related an impactful experience during Adoration that made him understand and realize Jesus saw him and was calling him to serve in the priesthood. After 2 years at UI, he enrolled at the Immaculate Heart of Mary Seminary in Minnesota and is now studying in Rome for the next 5 years. He said during his time at the Newman Center he learned how to accept himself and felt the Lord pulling him in.

# **Ways to Partner**
